Timeframe: prior to the end of the project cycle in 2017.</p>	Accepted	<p>The WFP Country Office will finalize a CO Capacity Development Plan, which would cover the activities undertaken under all CO projects, including DEV 200176 and Dev 200662.</p> <p>With regard to Dev 200176, the WFP Country Office is supporting a National Comprehensive Assessment of the school meals programme which includes a capacity gap analysis. The assessment, together with a System Approach to Better Education Results (SABER) exercise¹, will feed into the formulation of a National School Meals Implementation Strategy (NIS), which includes a National Capacity Development Plan as one of its key components. <p>Recommendation 7: The CO, in extensive collaboration with the relevant cooperating ministries, should seek to establish a Programme Management Unit (PMU) for project oversight. The PMU should have an assigned budget for management and monitoring tasks currently carried out by WFP and cooperating partners. Timeframe: as soon as possible, and certainly prior to the end of the project cycle in 2017.</p>	Accepted	<p>The WFP Country Office will continue to lobby for the establishment of a School Meals Unit under the Ministry of Education and Science, including during formulation of the budget of the National Implementation Strategy (NIS) with a view to the creation of a PMU by the end of 2017.</p> <p>However, this will require that a number of constraints be overcome, including the existing Government moratorium on hiring of additional staff and Government budget limitations.</p> <p>In order to address this recommendation and overcome the existing bottlenecks:</p> <ol style="list-style-type: none"> 1. Accepted	The WFP Country Office, jointly with IWC and key line ministries (MoES, MoH), will facilitate the development of a handover plan. The handover plan will build on the 2015 SABER exercise, the results of National Comprehensive Assessment of the school meals programme and the lessons learnt from process of design of the NIS.
